In response to your request regarding the work "REPORT OF FACTUAL FINDINGS FROM AGREED-UPON PROCEDURES PERFORMED FOR THE FINANCIAL YEAR 2019 AND FOR THE PURPOSE OF THE COMPANY'S REGISTRATION IN THE REGISTER OF GREEK AND FOREIGN NON-GOVERNMENTAL ORGANIZATIONS (NGOs) OF THE GREEK MINISTRY IMMIGRATION AND ASYLUM ACCORDING TO JOINT MINISTERIAL DECISION 3063/2020 (GOVERNMENT GAZETTE B '1382 / 14-4-2020)" we would like to submit our engagement letter with respect to the aforementioned work.

1. Scope

This letter is to confirm our understanding of the terms and objectives of our engagement and the nature and limitations of the services that we will provide to ONE HAPPY FAMILY – NON-GOVERNMENTAL ORGANIZATION (the "Company"). Our engagement will be conducted in accordance with the International Standard on Related Services 4400 applicable to agreed-upon procedures engagements and we will indicate so in our report.

2. Work description

We have agreed to perform the following procedures and report to you the factual findings resulting from our work:

- 1. We will review the articles of association of the Company and trace its content with the data declared to the competent Tax Authorities (i.e. purpose, legal representative and registered office of the Company, etc).
- 2. We will compare the amounts included in the Condensed Income Statement prepared by the Company for the period 01/01/2019 31/12/2019 and submitted to the Ministry of Immigration and Asylum with the formal accounting books and records kept by the Company.

- 3. We will verify that the monitoring of the projects implemented by the Company and required by specific considerations of the individual financing agreements is being performed in separate accounting records and distinct Bank Accounts.
- 4. We will examine, on a sample basis, income and expenses and other supporting documentation posted in the Company's accounting books and records for the period 01/01/2019 31/12/2019 and verify the appropriateness of the recordings in accordance with tax legislation and accounting framework. It should be noted that the total accounting entries for the period 01/01/2019 31/12/2019.
- 5. We will verify that the sample of income and expenses examined has been posted accurately to the proper accounts and in the context of the appropriate project.
- 6. Where applicable, we will cross-check the expenses made to the relative agreements and supporting evidence.
- 7. We will verify the timely submission to the Tax Authorities of the quarterly statements including all contracts and agreements with third parties.
- 8. We will verify the proper payment of the expenses examined in our sample through the banking accounts kept by the Company.
- 9. We will verify the proper collection of the income examined in our sample through the banking accounts kept by the Company.
- 10.We will perform bank reconciliations for the period 01/01/2019 31/12/2019.
- 11.For the sample of the expenses selected, we will examine the appropriateness of the legal deductions made in favor of the Greek State and the Insurance Funds.
- 12.We will verify the proper and timely submission to the Tax Authorities and the Insurance Organizations of all statements and declarations prescribed by the relative legislation in force (VAT, FMY, Stamp Declaration, Income Tax etc).
- 13. For the sample of the expenses selected, we will verify the proper settlement of the legal deductions made in favor of the Greek State and the Insurance Funds with the use of bank accounts.
- 14.We will examine on an annual basis that payroll lists have been completely and accurately posted to the accounting books and records for the period 01/01/2019 31/12/2019.
- 15. We will trace the data included in the staff statement submitted to the Labor Authorities with the relevant payroll lists for the period 01/01/2019 31/12/2019.



16. For the sample of the expenses selected, we will verify the proper settlement of the Company's obligations against its personnel and other third parties based on rules and guidance prescribed by the relative legislation in force.

The procedures that we will perform are solely to assist you in the registration of the Company in the Register of Greek and Foreign Non-Governmental Organizations (NGOs) as prescribed in Joint Ministerial Decision 3063/2020 (Government Gazette B '1382 / 14-4-2020).

The procedures that we will perform will not constitute an audit or a review made in accordance with International Standards on Auditing or International Standards on Review Engagements and, consequently, no assurance will be expressed. Our report is not to be used for any other purpose and is solely for your information.

3. Deliverables

Upon completion of the agreed-upon procedures we will issue a report of factual findings.

4. Timing

We will plan and co-ordinate our work in order to meet the reporting deadlines communicated to us by local management.

To achieve this objective, we will agree in writing before we begin this work, the information that we will require the Company to prepare and the date the information is to be received. Delays from your part in providing the information on the dates that have been agreed between us may result in delays on our part with respect to our deliverable within the agreed timetable and/or an increase in our fees.

Moreover, such delays may give rise to violation of the applicable legislation from your part, for which we shall not be held liable.

5. Fees

Our fees are based on the time spent by our professional staff in conducting the work and on the degree of assistance provided to us by the Company by abiding to our mutually agreed closing arrangements. Based upon our experience and the fact that the Company will provide to us the greatest possible assistance without any delays and that no problems will arise that were not obvious at the beginning of our work, we estimate our fee to be EUR 900,00. Our total fee is subject to V.A.T. at the current rate of 24%.
